I hereby authorize PEOPLE 2.0 to initiate and make credit entries and debit entries (for the purpose of adjusting any credit entries made in error to my account) at the indicated financial institution and I hereby authorize the indicated financial institution to accept and post such entries to my account. The forgoing authorization is solely for the purpose of facilitating automatic payroll deposit.

IMPORTANT: I understand it may take up to forty-eight (48) hours after PEOPLE 2.0 transmits my funds before they are posted to my account. Further, I understand that it is my responsibility to verify the crediting of funds by my financial institution prior to writing checks against my account.

This authorization is effective until I cancel my direct deposit, by delivering written notice of cancellation to PEOPLE 2.0 at least five business days prior to the desired termination date. However, I understand that this authorization will automatically terminate on the first of the month following sixty (60) consecutive days of inactivity. After becoming inactive, I will have to complete a new Authorization Agreement before PEOPLE 2.0 will initiate any further automatic payroll deposits. PEOPLE 2.0 may terminate this authorization agreement at any time.

I hereby authorize PEOPLE 2.0 to provide a copy of this authorization only as necessary for purposes of automatic payroll deduction.
